- B. The Technical Financial part of the Bids for Upgradation of road and C.D works with maintenance for **04** packages under PMGSY II (**RRP-II AF/G&CR**) were considered as detailed below: -

01. Package BR33P2R-01, Tender Id-92141 (Works Div. Pupari)

- (i) The work covered under the Package is for Upgradation of roads & C.D works with maintenance of MRL02-REO Sandwara To Patdaura (Tender Id-92141) of total length 7.052 km. The estimated cost of the work is Rs. 356.11387 Lakh.
- (ii) 01 bidder namely Abhiraj Kumar (Bid Id-400997) participated in the bid.

As per evaluation of Part I of bids approved by the Technical Bid Evaluation Committee, **Abhiraj Kumar** was declared as having qualified to be eligible for opening of Part II bids. [Single bid is also allowed as per Clause 2.61 of guidelines on Technical Bid of Goods, Works, and Non-Consulting services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers (January 2011 revised July 2014)].

(iii) The single responsive bid is of **Abhiraj Kumar.** Total Amount quoted by the bidder is **Rs 356.11387** Lakh for item rate contract. This is **equal to** the Bid Value Rs **356.11387** Lakh.

(iv) The available Bid Capacity of the lowest bidder (Abhiraj Kumar) works out to be Rs 892.129 Lakhs (446.06449*1*2-0 lakhs) which is more than the total bid value of works. Thus, the lowest evaluated responsive bidder Abhiraj Kumar satisfies the bid capacity criteria. (Clause 4.6 of ITB)

(v) The Technical Bid Evaluation Committee recommends to award the Contract for Package BR33P2R-01to the lowest evaluated responsive bidder for bid amount Rs 356.11387 Lakh which is equal to the Bid Value Rs 356.11387 Lakh.

(vi) The Bid Accepting Authority has accepted the recommendations of the Technical Bid Evaluation Committee and has decided to award the contract for Package BR33P2R-01 to Abhiraj Kumar for bid amount Rs 356.11387 Lakh.

Package BR34P2R-08, Tender Id-92142 (Works Div. Siwan-1) 02.

The work covered under the Package is for Upgradation of roads & C.D works with maintenance of MRL01-Atarsua to Kalyanpur (Tender Id-(i) 92142) of total length 3.04 km. The estimated cost of the work is Rs. 170.82 Lakh.

03 bidder namely BALINDAR CHAUDHARY (Bid Id-401256), IRSHAD (ii) KHAN (Bid Id-401216) & PRAMOD KUMAR SINGH (Bid Id-401211) participated in the bid.

As per evaluation of Part I of bids approved by the Technical Bid Evaluation Committee, following bidders were declared as having qualified to be eligible for opening of Part II bids:-

- (a) BALINDAR CHAUDHARY
- (b) IRSHAD KHAN
- (c) PRAMOD KUMAR SINGH
- The lowest responsive bid is of BALINDAR CHAUDHARY. Total Amount quoted by the bidder is Rs 149.95409 Lakh for item rate contract. This is (iii) 12.22% less than the Bid Value Rs 170.82 Lakh.
- Capacity of the lowest bidder (BALINDAR Bid available The (iv) CHAUDHARY) works out to be Rs 988.180 Lakhs (494.09*1*2-0 lakhs) which is more than the total bid value of works. Thus, the lowest evaluated responsive bidder BALINDAR CHAUDHARY satisfies the bid capacity criteria. (Clause 4.6 of ITB)
- The Technical Bid Evaluation Committee recommends to award the Contract (v) for Package BR34P2R-08 to the lowest evaluated responsive bidder for bid amount Rs 149.95409 Lakh which is 12.22% below than the Bid Value Rs 170.82 Lakh.
- The Bid Accepting Authority has accepted the recommendations of the Technical Bid Evaluation Committee and has decided to award the contract (vi) for Package BR34P2R-08 to BALINDAR CHAUDHARY for bid amount Rs 149.95409 Lakh.
- Package BR35P2R-03, Tender Id-90736 (Works Div. Supaul) 03.
- The work covered under the Package is for Upgradation of roads & C.D works with maintenance of MRL02-Supaul Sharrha S.H To Sukhpur (i) KaliPatti (Tender Id-90736) of total length 5.01 km. The estimated cost of the work is Rs. 289.27953 Lakh.
- 02 bidder namely ANUJ KUMAR (Bid Id-40052) & MS THAKUR (ii) CONSTRUCTION (Bid Id-400163) participated in the bid.

As per evaluation of Part I of bids approved by the Technical Bid Evaluation Committee, following bidders were declared as having qualified to be eligible for opening of Part II bids:-

(a) ANUJ KUMAR

(b) MS THAKUR CONSTRUCTION

(iii) The lowest responsive bid is of **ANUJ KUMAR**. Total Amount quoted by the bidder is **Rs 285.55476** Lakh for item rate contract. This is **1.29%** less than the Bid Value Rs **289.27953** Lakh.

(iv) According to Cl. 4.4 C of ITB-"To qualify for a package of contracts made up of this and other contracts for which bids are invited in the Invitation for Bids, the bidder must demonstrate having experience and resources sufficient to meet the aggregate of the qualifying criteria for the individual contracts."

The bidder ANUJ KUMAR has participated in two packages namely BR20P2R-09 & BR35P2R-03 under the same NIT No.-RWD/PMGSY-II/RRP-II/HQ/ET-19-20/05. Bidder's experience, resources sufficient to meet the aggregate of the qualifying criteria for the package BR20P2R-09 & BR35P2R-03 are as detailed below:-

- (v) The available Bid Capacity of the lowest bidder (ANUJ KUMAR) works out to be Rs 379.438 Lakhs (227.25*1.08*1*2-111.422 lakhs) which is more than the total bid value of works. Thus, the lowest evaluated responsive bidder ANUJ KUMAR satisfies the bid capacity criteria. (Clause 4.6 of ITB)
- (vi) The Technical Bid Evaluation Committee recommends to award the Contract for Package BR35P2R-03 to the lowest evaluated responsive bidder for bid amount Rs 285.55476 Lakh which is 1.29% below Bid Value Rs 289.27953 Lakh.
- (vii) The Bid Accepting Authority has accepted the recommendations of the Technical Bid Evaluation Committee and has decided to award the contract for Package BR35P2R-03 to ANUJ KUMAR for bid amount Rs 285.55476 Lakh.

04. Package BR27P2R-06, Tender Id-94111 (Works Div. Dhamdaha)

The work covered under the Package is for Upgradation of roads & C.D works with maintenance of MRL02-Dhamdaha A.D.B Road to Nipania Milik (Tender Id-94111) of total length 13.41 km. The estimated cost of the work is Rs. 1459.15726 Lakh.

(ii) 02 bidder namely SARIKA DEVI (Bid Id-407614) & PREM KUMAR (Bid Id-407603) participated in the bid.

As per evaluation of Part I of bids approved by the Technical Bid Evaluation Committee, following bidders were declared as having qualified to be eligible for opening of Part II bids:-

(a) SARIKA DEVI (b) PREM KUMAR

- (iii) The lowest responsive bid is of **SARIKA DEVI.** Total Amount quoted by the bidder is **Rs 1457.55012** Lakh for item rate contract. This is **0.11%** less than the Bid Value Rs **1459.15726** Lakh.
- (iv) The available Bid Capacity of the lowest bidder (SARIKA DEVI) works out to be Rs 2820.066 Lakhs (1499.85*1.08*1*2-419.61 lakhs) which is more than the total bid value of works. Thus, the lowest evaluated responsive bidder SARIKA DEVI satisfies the bid capacity criteria. (Clause 4.6 of ITB)
- (v) The Technical Bid Evaluation Committee recommends to award the Contract for Package BR27P2R-06 to the lowest evaluated responsive bidder for bid amount Rs 1457.55012 Lakh which is 0.11% below than the Bid Value Rs 1459.15726 Lakh.
- (vi) The Bid Accepting Authority has accepted the recommendations of the Technical Bid Evaluation Committee and has decided to award the contract for Package BR27P2R-06 to SARIKA DEVI for bid amount Rs 1457.55012 Lakh.
- C. The S.E / E.E, should ascertain the following facts before issuing the work order of the sanctioned bids: -
- (i) The Administrative approval and technical sanction of the scheme have been accorded and BOQ has been approved by the competent authority. If the amount of BOQ is more than admissible limit then revised administrative approval should be obtained.

- (iii) Package no., Road Name, BOQ amount, amount of TS, A.A, Quoted rate and bid capacity are correct.
- (iv) The bidder is not defaulter/blacklisted or his name is not in pending list of work.
