For selection of Service Provider Agency (SPA) to supply State Quality Monitor for 2nd tier Quality Management for PMGSY works under State Quality Co-ordinator

The state has onus of building approximately 55,219 km of rural roads under Pradhan Mantri Gram Sadak Yojana. The PMGSY is a programme of MORD, Government of India aims at providing all weather road connectivity to eligible unconnected habitations.

To monitor the quality of all PMGSY works a "Three Tier Quality Management system" has to be setup as per PMGSY Guidelines.

BRRDA invites eligible Service Provider Agency to indicate their interest to supply State Quality Monitor for 2nd tier Quality Management. Total 100 number of SQMs are required.

SLNO	Package No	No of SQM required	Minimum Qualification/requirements for eligibility
1	Package 1	25	1- The candidate should be minimum Graduate/equivalent qualification in Civil Engineering from recognized University
2	Package 2	25	2- The candidate should have retired from the post not below the level of Executive Engineer or equivalent from Govt. Organization, Central/State Public sector undertaking (PSUs)
3	Package 3	25	3- No candidate would be allowed to work as SQM after completing the age of 70 years, therefore, the candidate should not have attained the age of 67 years on the date of Selection Committee Meeting so that the candidate is able to work as SQM for at least 3 years subject to satisfactory performance.
4	Package 4	25	4- The candidate should possess the experience of working in the field of construction of roads/bridges for at least 5 years in last 10 years before retirement from Government Service/Govt. Organization, Central/State Public sector undertaking (PSUs). Also in last 5 years, he should have worked at least for 2 years in the field of roads/bridges (any field out of Planning and Designing, Execution or Management of construction or maintenance of roads/bridges).
			5- The candidate should be conversant with working basic knowledge of computer/smart phones and familiar with uses of mobile app application.
			6- The Upper age limit for working as SQM shall be 70 years subject to satisfactory performance and good conduct.

Note – The Number of SQMs may be changed as per requirement of department.


Interested agency should provide information demonstrating that they have the required qualifications and relevant experience to perform the above services. The short listing criteria are:

- (i) The Bidder should be a legally registered entity in India, registered as Service Provider Agency since last 5 (Five) years as on the date of submission of bid. The bidder must be a company registered under the Indian Companies Certification Act.
- (ii) The Bidder should have Minimum 2 years of Experience working with any Agency of Central/State government/ PSU as only Technical Manpower (Civil Engineers) Supply Agency.
- (iii) The firm should have minimum average annual turnover of Rs. 7.75 crores (Rs Seven crore seventy five lakh only) during last 3 consecutive financial years.
- (iv) The Bidder must have valid GST registration certificate, EPF Registration & ESIC Registration as on the date of submission of bid.
- (v) The Bidder should not be black listed by any entity.
- (vi) The Bidder may be apply more than one package but EMD for each package is required separately
- (vii) The relevant document/RFP can only be downloaded from www.rwdbihar.gov.in

Service Provider Agency may associate with other firms in the form of joint venture to enhance their qualification. Service Provider Agency will be selected in accordance with the selection based on the **Least Cost Selection method.**
