**INVITATION FOR BIDS (IFB) – Retender****(NIT No- RWD/MMGSY/WORLD BANK/HQ/ET/21-07)**

The Government of India has received a loan/credit from the World Bank for Construction and Maintenance towards the cost of Bihar Rural Roads Project (Mukhya Mantri Gram Sampark Yojana) and intends to apply a part of the funds to cover eligible payments under the contracts for construction of works as detailed in the Table below. Bidding is open to all bidders from eligible source countries as defined in the bidding document.

Engineer-in-Chief, Rural Works Department, on behalf of Governor of Bihar invites **Item rate** tenders in electronic tendering system under **Mukhya Mantri Gram Sampark Yojana (MMGSY)** funded by World Bank for each of the following packages works including their maintenance after construction of roads for five years from the eligible and approved Contractors registered with RWD/RCD/CPWD/MES/Railways/Other State/Central Govt. department.\*

- The Government of India has received/applied for/intends to apply for financing from the World Bank towards the cost of Bihar Rural Roads Project and intends to apply a part of the funds to cover eligible payments under the contracts<sup>1</sup> for construction of works as detailed below.
- Bidding will be conducted through National Competitive Bidding procedures agreed with the World Bank. Bidding is open to all eligible bidders as defined in the World Bank's Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers, January 2011, revised in July 2014.
- Bidders from India should, however, be registered with the Government of Bihar or other State Governments/Government of India, or State/Central Government Undertakings. Bidders from India, who are not registered as above, on the date of bidding, can also participate provided they get themselves registered by the time of contract signing, if they become successful bidders. **Bidders are advised to note the clauses on eligibility (Section I Clause 4) and minimum qualification criteria (Section III – Evaluation and Qualification**

**Criteria), to qualify for the award of the contract.** In addition, please refer to paragraphs 1.6 and 1.7 of the World Bank's Guidelines setting forth the World Bank's policy on conflict of interest.

5. The Engineer-in-Chief, Rural Works Department, Bihar on behalf of Governor of Bihar invites the **item rate** bids in electronic tendering system for construction of roads under Mukhya Mantri Gram Sampark Yojana in the various districts of Bihar for **01 Number** of package with estimated cost totalling to **4.99** Crore including their maintenance for five years from the eligible contractors registered with RWD/RCD/CPWD/MES/Railways/Other State/Central Govt. Departments\*. Non-registered bidders may submit bids; however, the successful bidders must get registered in appropriate class with Rural Works Department, Bihar before signing the contract..
6. Bidding documents are available online on [www.pmgsytenders.gov.in](http://www.pmgsytenders.gov.in) from **29.09.2021 (09:00 Hours)** to **28.10.2021 (15:00 Hours)** for a non-refundable fee as indicated in the table, in the form of Demand Draft (DD) on any Scheduled/Nationalized bank payable at **10,000/-** in favour of Executive Engineer, R.W.D of the concerned Works Division (Demand draft is to be submitted subsequently as per the procedure described in paragraph 9 below). Bidders will be required to register on the website, which is free of cost. The bidders would be responsible for ensuring that any addenda available on the website is also downloaded and incorporated.
7. For submission of the bid, the bidder is required to have Digital Signature Certificate (DSC) from one of the Certifying Authorities authorised by Government of India for issuing DSC. Aspiring bidders who have not obtained the user ID and password for participating in e-procurement in this Project, may obtain the same from the website: [www.pmgsytenders.gov.in](http://www.pmgsytenders.gov.in).
8. All Bids must be accompanied by a bid security of the amount specified for the work in the table below, drawn in favour of Executive Engineer, R.W.D of the concerned Works Division. Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid. Procedure for submission of bid security is described in Para 9.
9. Bids must be submitted online on [www.pmgsytenders.gov.in](http://www.pmgsytenders.gov.in) on or before **28.10.2021 (15:00 Hours)** and the 'Technical Part' of the bids will be opened online on **28.10.2021 at 15.30 hours**. The "Financial Part" shall remain unopened in the e-procurement system until the second public Bid opening for the financial part. Any bid or modifications to bid (including discount) received outside e-procurement system will not be considered. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time. The electronic bidding system would not allow any late submission of bids.
10. The bidders are required to submit (a) original demand drafts towards the cost of bid document and registration on e-procurement website (if not previously registered); (b) original bid security in approved form; and (c) original affidavit regarding correctness of information furnished with bid document as per provisions of Clause 12.3 of ITB to the either **concerned Chief Engineer/ Superintending Engineer, works circle /Executive Engineer, Works Division R.W.D, Bihar**, before the opening of the technical part of the Bid i.e. before **28.10.2021 up to 15:00 Hours**, either by registered post/speed post/courier or by hand, failing which the bids will be declared non-responsive and will not be opened.





11. A pre-bid meeting will be held on **06.10.2021 at 11:00 hrs. at the office of Concerned Circle office** to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in ITB Clause 7.4 of 'Instructions to Bidders' of the bidding document. Bidders are advised to download the bidding document prior to the pre-bid meeting in order for bidders to have a good understanding of the scope of work under this contract for discussion and clarification at the pre-bid meeting.
12. Other details can be seen in the bidding documents. The Employer shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, the Employer shall not be liable for any information not received by the bidder. It is the bidders' responsibility to verify the website for the latest information related to this bid.
13. As per departmental letter No. 511(E) Patna, dated 29.01.2020, it is mandatory to submit the advocates welfare fund of Rupees 25.00/- in the affidavit for all tenders.
14. As per departmental letter No. 14/ENC-03-21/2021-489(E)/ Patna, dated 28.01.2021, it is mandatory to submit the valid character certificate in technical part of the bid for all tenders.
