#### EXPRESSION OF INTEREST

#### 1. Introduction:

Rural Road brings multiple Socio-Economic reforms in Rural Areas which forms a strong base for development of a Nation and it has a positive impact on Agriculture, Employment Generation, Industry, Health, Education, Transport Facilities, Urbanization and many more. Government Of Bihar (GOB) is dedicated in providing all round Social and Economic development through improvised connectivity of Rural Roads keeping in view the safety of its users. This is where role of Road Safety Audit (RSA) comes into play. The various reasons of accidents are listed below

- Defective Construction of road (Absence of Bus Lay by , Truck Lay byes
- Improper Super Elevations, Shoulders
- · Poor Maintenance of Roads
- Improper Road Signage, Markings, Round About
- Adherence to Traffic Rules and Regulations
- Overloaded Vehicles
- Materials projecting outside the Vehicular body
- Driving beyond Control Speed
- Driving in abnormal condition
- Use of Mobile Phones while driving

#### And various other reasons

A Road Safety Audit (RSA) is defined as "the formal safety performance examination of an existing or future road or intersection by a multidisciplinary team. It qualitatively estimates and reports on potential road safety issues and identifies opportunities for improvements in safety for all road users.

#### 2. Objective:

Objective of the RSA is to assess projects for potential accident elimination / reduction on the basis of road user knowledge, attributes and skills, day/night, wet/dry road conditions.

Since our roads are designed and constructed by striking a socio-economic balance between safety, accessibility, environment, economy and locally available material and skill, RSA may determine the shortfall in safety, but may not be able to correct the deficiencies in pavement design, drainage, and appropriate space standard etc.

#### 3. Shortlisting Criteria

a) Annual Turnover

- Annual turnover of any one of the last five financial years i.e. from 2012-2013 to 2016-2017 updated to the current financial year shall be minimum 25 crores (An Audited financial report shall be furnished)
- For arriving at updated value, turnover of any financial year shall be multiplied by the enhancement factor corresponding to that year

#### b) Experience

- Assignment involving drafting/reviewing road safety policy framework in any of the developing country
- Institutional assignment involving review of and preparation of various Manuals/Guidelines on Road Safety
- Assignment involving Road Safety Training/Capacity Building
