EXPRESSION OF INTEREST (EOI)

For selection of Service Provider Agency (SPA) to supply Technical manpower for the Quality Management Cell (QMC) set up within Rural Works Department, Govt. Of Bihar.

Notice No RWD (QMC) -01/2019-20 date:

The state has onus of building approximately 1,31,626 km of rural roads under its centrally sponsored Pradhan Mantri Gram Sadak Yojana and various State Schemes such as Mukhya Mantri Gram Sampark Yojana, Gramin Tola Sampark Nischay Yojana etc.

To monitor the quality of all the above State Schemes, the Department has set up a Quality Management Cell which monitors the quality of schemes through its "Three Tier Quality Management system".

RWD invites eligible Service Provider Agency to indicate their interest in supplying technical manpower for the Quality Monitoring Cell (QMC) in the form of Independent Engineer who is to act as 2nd Tier Quality Management. Total number of IE required is108. It is proposed to take the services of 36 nos. of IEs for the each of the following packages by one SPA. One IE will cater to 1 PIU (Works Division).

Interested agency should provide information demonstrating that they have the required qualifications and relevant experience to perform the above services. The short listing criteria are:

- (i) The Bidder should be a legally registered entity in India, registered as Service Provider Agencysince last 5 (Five) years as on the date of submission of bid. The bidder must be a company registered under the Indian Companies Act Certification will be preferred.
- (ii) The Bidder should have Minimum 2 years of Experience working with any Agency of Central/State government/ PSU as Manpower Supply Agency.
- (iii) The firm should have minimum average annual turnover of Rs. 5.00 crores (Rs five crores only) during each last 3 financial years
- (iv) The bidder must have valid GST registration certificate, EPF Registration & ESIC Registration as on the date of submission of bid.
- (v) The Bidder should have a local office at Patna and should provide supporting documents for the same.
- (vi) The bidder should not be black listed by any entity.

Bidder can bid for more than one packages but work will be allotted only for 1 (one) Package of his choice if the bidder succeeds in more than 1 package. Service Provider Agency may associate with other firms in the form a joint venture to enhance their qualification.

Service Provider Agency will be selected based on the Least Cost Selection method.
