**selection of Service Provider Agency (SPA) to Supply Technical Manpower to the
Regional Laboratories of RWD in the State of Bihar.**

1. The Rural Works Department has received financing from the International Development Association (IDA) (the "Bank") in the form of a "credit" toward Bihar Rural Roads Project. The BRRDA, an implementing agency of the RWD, intends to apply a portion of the proceeds of this credit for eligible payments towards the consulting services: Selection of Service Provider Agency (SPA) to Supply Technical Manpower to the Regional Laboratories of RWD in the State of Bihar for which the EOI is being issued.
2. To cater to the needs of total quality management in the implementation of rural roads in the state of Bihar, Rural Works Department has set up fully fledged and well equipped 10 no. of sophisticated Regional Laboratories at Patna, Gaya, Sasaram, Bhagalpur, Saharsa, Purnea, Muzaffarpur, Darbhanga, Chapra and Bettiah. In order to fill the manpower constraint, Rural Works Department, Govt. of Bihar invites eligible service providing agency to indicate their interest in providing the services of Research Officer, Research Assistants and Lab Attendants for Regional Lab in Bihar under 3 Packages.

3. Eligible firms ("Consultants") are invited to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services.

The short listing criteria are:

- a) Past experience in carrying out similar type of assignment over the past (5) years.
- b) Annual turnover of the firm for at least the last three years. (FY 2016-17, 2017-18 & 2018-19) showing at least average annual turnover equivalent to INR 2.00 Cr.
- c) The bidder should have a positive net worth in last financial years preceding the current financial year.

d) The bidder should not have been blacklisted /debarred/terminated/ declared having dissatisfactory performance with any state/central government organization/PSU Organization/bilateral/multilateral funding agencies.

Expression of Interest shall be not more than 100 pages and must include:

- Introductory letter on letter head (with complete contact details- name of the contact person, mailing address, telephone, fax, e-mail etc.) explaining how the firm is best to deliver the task.
- Organization profile.
- Annual turnover of the firm for at least the last three years. (FY 2016-17, 2017-18 & 2018-19)
- Short note on the similar projects implemented by the firm pertaining to the short listing criteria along with the contact details of past clients.
- The EOI should contain sufficient supporting documents to substantiate the claim of the consultant towards their qualification as per the short listing criteria.
- An undertaking by the bidder that they are not blacklisted /debarred/terminated/ declared having dissatisfactory performance with any state/central government organization/PSU Organization/bilateral/multilateral funding agencies.
