विषयांकित दिनांक- 08.01.2021 को सम्पन्न Bid Accepting Authority (विभागीय निविदा समिति) की बैठक की कार्यवाही संलग्न कर भेजते हुए निदेश दिया जाता है कि आवंटित कार्यों के त्वरित कार्यान्वयन हेतु अगले दो दिनों के अन्दर संबंधित निविदाकार को कार्यादेश (Letter of Acceptance) निर्गत करें तथा उसकी एक प्रति ज्ञापन लगाकर ब्राडा को मेल के द्वारा उपलब्ध कराना सुनिश्चित करें। कार्यादेश निर्गत करने के अगले पन्द्रह दिनों के अन्दर संबंधित निविदाकार के साथ एकरारनामा करते हुए तत्क्षण एकरारनामा की विवरणी OMMAS पर Upload कराना भी सुनिश्चित किया जाय। निर्धारित समय सीमा में निर्दिष्ट कार्य का पूरा किया जाना अनिवार्य है।

Minutes of Bid Accepting Authority meeting for evaluation of Financial Bids of PMGSY RRP-II held on 8 / 2 / 2021


1. Presence:-
 - (i) Sri Pankaj Kumar Pal, Secretary, RWD-cum-Chief Executive Officer, BRRDA
 - (ii) Sri Sanjay Dubey, Additional Chief Executive officer, BRRDA-Cum-Secretary, BRRDA
 - (iii) Sri Ashok Kumar Mishra, Engineer -in- Chief, RWD
2. The Technical Financial part of the Bids for Construction of Bridge with maintenance for **01** package under PMGSY RRP-II was considered as detailed below:

A. Package BR-16R-153, Tender Id-103728 (Works Div. Manihari)


- (i) The work covered under the Package is for construction of Bridge works with maintenance of **one** bridge namely **JHAUA TO GARARUA (Tender Id-103728)** of total length **86.16** mtr. The estimated cost of the work is Rs. **312.44826** lakhs.
- (ii) **04** bidder namely **SINGH AND SONS INFRAGREEN PVT LTD (Bid Id-442107)**, **PUSHPA KUMARI (Bid Id-442155)**, **SANJAY KUMAR JHA (Bid Id-441988)** & **VISHAL ENTERPRISES (Bid Id-442139)** participated in the bid.

As per evaluation of Part I of bids approved by the Technical Bid Evaluation Committee, **SINGH AND SONS INFRAGREEN PVT LTD** was declared as having qualified to be eligible for opening of Part II bids. [Single bid is also allowed as per Clause 2.61 of guidelines on Technical Bid of Goods, Works, and Non-Consulting services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers (January 2011 revised July 2014)].


- (iii) The retendered single responsive bid is of **SINGH AND SONS INFRAGREEN PVT LTD**. Total Amount quoted by the bidder is Rs **290.60812** Lakh. This is **6.99%** less than the Bid Value Rs **312.44826** Lakh.
- (iv) The available Bid Capacity of the lowest bidder (**SINGH AND SONS INFRAGREEN PVT LTD**) works out to be Rs **460.03693** Lakhs (**432.64711*1*2-251.464-153.79329 lakhs**) which is more than the total bid value of works. Thus, the lowest evaluated responsive bidder **SINGH AND SONS INFRAGREEN PVT LTD** satisfies the bid capacity criteria. (Clause 4.6 of ITB)
- (v) The Technical Bid Evaluation Committee recommends to award the Contract for Package **BR-16R-153** to the lowest evaluated responsive bidder for bid amount Rs **290.60812** Lakh which is **6.99%** below Bid Value Rs **312.44826** Lakh.









- (vi) The Bid Accepting Authority has accepted the recommendations of the Technical Bid Evaluation Committee and has decided to award the contract for Package **BR-16R-153** to **SINGH AND SONS INFRAGREEN PVT LTD** for bid amount Rs **290.60812** Lakh.
3. The S.E / E.E, should ascertain the following facts before issuing the work order of the sanctioned bids: -
- (i) The Administrative approval and technical sanction of the scheme have been accorded and BOQ has been approved by the competent authority. If the amount of BOQ is more than admissible limit then revised administrative approval should be obtained.
- (ii) The bid security is as per clause 16 of ITB of MBD.
- (iii) Package no., Road Name, BOQ amount, amount of TS, A.A, Quoted rate and bid capacity are correct.
- (iv) The bidder is not defaulter/blacklisted or his name is not in pending list of work.
4. Executive Engineer should verify all the papers with original documents.
5. In case any mistake/error is found, it should be immediately intimated to the headquarter.
6. The Bid accepting authority has accepted the recommendations of the Technical Bid Evaluation committee and approved uploading of the results of the evaluation on the website.
