Minutes of Bid Accepting Authority meeting for evaluation of Financial Bids of PMGSY-II (RRP-II AF and AF-G & CR) held on 22/1 / 2021

A. Presence:-

(iii) Sri Ashok Kumar Mishra, Engineer -in- Chief, RWD

B. The Technical Financial part of the Bids for Upgradation of road and C.D works with maintenance for 02 packages under PMGSY II (RRP-II AF and AF-G & CR) was considered as detailed below:

01. Package BR04P2R-12, Tender Id-98819 (Works Div. Balia)

- (i) The work covered under the Package is for Upgradation of roads & C.D works with maintenance of MRL02-RAILWAY CROSSING NAYATOLA TO CHOKI (Tender Id-98819) of total length 4.86 km. The estimated cost of the work is Rs. 245.34388 Lakh.
- (ii) 03 bidder namely R K CONSTRUCTION (Bid Id-428267), Ram Balak singh construction pvt. Ltd. (Bid-42888) & EKTARAJ CONSTRUCTION PVT LTD (Bid Id-428900) participated in the bid.

As per evaluation of Part I of bids approved by the Technical Bid Evaluation Committee, following bidders were declared as having qualified to be eligible for opening of Part II bids:-

(a) R K CONSTRUCTION

(b) Ram Balak singh construction pvt. Ltd.

(c) EKTARAJ CONSTRUCTION PVT LTD

- (iii) The lowest responsive bid is of R K CONSTRUCTION. Total Amount quoted by the bidder is Rs 227.30649 Lakh for item rate contract. This is 7.35% below than the Bid Value Rs 245.34388 Lakh.
- (iv) The available Bid Capacity of the lowest bidder (**R K CONSTRUCTION**) works out to be Rs **1958.56535** Lakhs (**719.802*1.08*1.08*1.08*1.08*1*2-0** lakhs) which is more than the total bid value of works. Thus, the lowest evaluated responsive bidder **R K CONSTRUCTION** satisfies the bid capacity criteria. (Clause 4.6 of ITB)

(v) The Technical Bid Evaluation Committee recommends to award the Contract for Package BR04P2R-12 to the lowest evaluated responsive bidder for bid amount Rs 227.30649 Lakh which is 7.35% below than the Bid Value Rs 245.34388 Lakh.

(vi) The Bid Accepting Authority has accepted the recommendations of the Technical Bid Evaluation Committee and has decided to award the contract for Package BR04P2R-12 to R K CONSTRUCTION for bid amount Rs 227.30649 Lakh.

Package BR18P2R-21, Tender Id-103149 (Works Div. Kishanganj-1) 02.

The work covered under the Package is for Upgradation of roads & C.D (i) works with maintenance of T02-BHAAGJHUNKI SE BELLGADI PIPRA (Tender Id-103149) of total length 6.00 km. The estimated cost of the work is Rs. 327.463 Lakh.

01 bidder namely PRADEEP KUMAR (Bid Id-443993) participated in the (ii) bid.

As per evaluation of Part I of bids approved by the Technical Bid Evaluation Committee, PRADEEP KUMAR was declared as having qualified to be eligible for opening of Part II bids. [Single bid is also allowed as per Clause 2.61 of guidelines on Technical Bid of Goods, Works, and Non-Consulting services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers (January 2011 revised July 2014)].

The single responsive bid is of PRADEEP KUMAR. Total Amount quoted (iii) by the bidder is Rs 327.45995 Lakh for item rate contract. This is 0.001%

less than the Bid Value Rs 327.463 Lakh.

The available Bid Capacity of the lowest bidder (PRADEEP KUMAR) (iv) works out to be Rs 1012.20192 Lakhs (433.9*1.08*1.08*1*2-0 lakhs) which is more than the total bid value of works. Thus, the lowest evaluated responsive bidder PRADEEP KUMAR satisfies the bid capacity criteria. (Clause 4.6 of ITB)

The Technical Bid Evaluation Committee recommends to award the Contract (v) for Package BR18P2R-21 to the lowest evaluated responsive bidder for bid amount Rs 327.45995 Lakh which is 0.001% below Bid Value Rs 327.463

Lakh.

- The Bid Accepting Authority has accepted the recommendations of the (vi) Technical Bid Evaluation Committee and has decided to award the contract for Package BR18P2R-21 to PRADEEP KUMAR for bid amount Rs 327.45995 Lakh.
- The S.E / E.E, should ascertain the following facts before issuing the work C. order of the sanctioned bids: -
- The Administrative approval and technical sanction of the scheme have been (i) accorded and BOQ has been approved by the competent authority. If the amount of BOQ is more than admissible limit then revised administrative approval should be obtained.
- The bid security is as per clause 16 of ITB of MBD. (ii)
- Package no., Road Name, BOQ amount, amount of TS, A.A, Quoted rate and (iii) bid capacity are correct.

- (iv) The bidder is not defaulter/blacklisted or his name is not in pending list of work.

- E. In case any mistake/error is found, it should be immediately intimated to the headquarter.
