Short Notice Inviting Re-tender (No.-RWD/MMGSY(NDB)/HQ/ET/09(R)/2024-25)

The Government of Bihar has a *loan no. [18IN01]* from New Development Bank (NDB) towards the cost of Rural Roads Project (Mukhya Mantri Gram Sampark Yojana) to cover eligible payments under the contracts for construction & maintenance of works as detailed in the Table-1 below. Bidding is open to all bidders from eligible source countries as defined in the bidding document.

Engineer-in-Chief, Rural Works Department, on behalf of Governor of Bihar invites, **SBD** based Percentage rate tender in electronic tendering system under **Mukhya Mantri Gram Sampark Yojana (MMGSY)** for each of the following works including their maintenance for five years from the eligible and approved Contractors registered with RWD/RCD/CPWD/MES /Railways/Other State/Central Govt. departments.


The Cost of Package and Earnest Money is indicative and the actual amount of Earnest Money will be as per uploaded BOQ. Cost of non-refundable Bid Document (Rs.10,000.00 for Bids costing more than Rs. 50 lakh and Rs. 5000 for Bids costing Rs. 15 lakh to Rs. 50 lakh) and Earnest Money will be submitted online (PMGSY e-tender online Account-through PMGSY e-tender portal by Internet Banking only). All concerned please note that the bidding process will not move onward if the Bid Document's Cost (Tender Fee) and Earnest Money is not paid through PMGSY e-tender portal by Internet Banking. No other form of Bid Document cost and Earnest Money will be accepted. In case the bid of non-responsive bidder is reconsidered whose EMD has been refunded automatically, will be collected and refunded manually in the shape of fixed deposit receipt.

The bidders are required to submit scan copies of the following documents at the time of submission of bid and original copies at the time of signing of contract Bond in the office of the Concerned Executive Engineer.

- (a) Affidavit (original) regarding correctness of information furnished with bid document as per prescribed Format of SBD (Section-6).
- (b) Character certificate (Original)
- (c) GST Clearance Certificate

If any uploaded paper found forged and fabricated, then appropriate action will be taken against the bidder as per clause 32 of ITB and clause 11 of "Bihar Contractor Registration Rule (Rural Works Department) 2007".

1. The Earnest Money will be applicable on the sanction cost of B.O.Q only and it will be as follows: -
 - (i) For Works Costing up to 10 crore- 2% of Total estimated cost. (Multiple of Rs. 100/-)
 - (ii) For Works Costing more than 10 Crore- Rs. 20 lakhs plus 1% of the excess cost of the total Estimated cost over and above 10 crore. (Multiple of Rs. 1000/-)
2. All documents uploaded online by the bidders including affidavits shall be considered in technical bid evaluation but after award all the documents may be duly verified.
3. As per notification no.-447(s), dated-16.01.2020 issued by the Road Construction Department, Government of Bihar and RWD letter no.-मुअ०-4(मु०) विविध (कार्य) 23-291/2014-292 (अनु०) dated 17.01.2020, it is to amend that in the percentage rate tenders the maximum lower limit of the rate quoted by the tenderer is herewith deleted.
4. The tenderer is liable to submit Additional Performance Guarantee for the unbalanced bid as per notification no.-447(s), dated-16.01.2020 issued by the Road Construction Department, Government of Bihar and in accordance with Clause-26.3 of ITB and Clause-46 Part-1 General Condition of the Standard Bidding Document (SBD).
5. As per letter No.-4192 dated: 29.07.2024 of RWD, Govt. of Bihar, successful bidder has to submit character certificate before the agreement of awarded work.





Short Notice Inviting Re-Tender (No.-RWD/MMGSY(NDB)/HQ/ET/09(R)/2024-25)

SECTION 1

1. The Bidder may submit bids for any number of the work Packages. Bidders are advised to note the minimum qualification criteria specified in Clause 4 of the Instructions to qualify for the award of the contract and also inspect the site before bidding.
2. Time allowed for completion of each package is 12 months, including the rainy season. If the size of the package is greater than 10 Crore then Construction / Time of completion shall be enhanced from 12 Months to 18 Months.
3. Earnest Money and cost of bid will be submitted online (PMGSY e-tender online Account-through PMGSY e-tender portal by Internet Banking only). All concerned please note that the bidding process will not move onward if the Bid Document's Cost (Tender Fee) and Earnest Money is not paid through PMGSY e-tender portal by Internet Banking. No other form of Bid Document cost and Earnest Money will be accepted.
4. The bids shall remain valid for acceptance for a period of 180 (One Hundred Eighty) days after deadline date for bids submission. Bids once submitted cannot be withdrawn. If any bidder/tenderer withdraws his bid/ tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
5. A set of bidding documents will be available online on website <http://pmgsytendersbih.gov.in>. Cost of bid document as per the amount specified in the Appendix to ITB non-refundable will be deposited online.
6. Bids must be submitted on-line on website <http://pmgsytendersbih.gov.in>
7. Bids submitted on-line must be accompanied with a scanned copy of Affidavits.
8. Each bidder is required to furnish information on prescribed Performa Section-3 Qualification Information of the Bidders required for evaluation of the bid.
9. The date and time of opening of the financial bid shall be notified on website <http://pmgsytendersbih.gov.in> This is conveyed to the bidder automatically through an e-mail message. The Financial bids shall be opened accordingly on-line on the same website <http://pmgsytendersbih.gov.in>. All communication with the bidder will be done through e-mail message.
10. A bidder shall not be permitted to bid for works in the Circle responsible for award and execution of contracts in which his or his spouse's near relatives (defined as first blood relations, and their spouses) is posted as Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer and Junior Engineer (both inclusive).
11. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the State/Central Government is allowed to work as a Contractor for a period of two years after his retirement from Government service, without Government permission. This contract is liable to be cancelled if either the Contractor or any of his employees is found to be such a person who had not obtained the permission of the Government as aforesaid before submission of the tender or engagement in the Contractor's service.
12. Bid documents and other details consisting of qualification information and eligibility criterion of bidders, plans, specifications, drawings, the schedule of quantities of the various classes of work to be done and the set of terms & conditions of contract to be compiled with by the contractor can be seen in the office of the concerned Executive Engineer mentioned corresponding to the respective package. All these documents can be downloaded from the website <http://pmgsytendersbih.gov.in> directly.
13. The Department may add or delete any of the condition required for execution of any work.
14. GST Clearance Certificate will be required before agreement from the Successful Bidder Only
15. Bidder must submit G.S.T Registration, Power of attorney/Partnership deed/MOU of private limited company at the time of submission of bid.
16. Other details can be seen in the bidding documents.
17. Qualified bidders have to be registered with RWD (if not already registered) before signing of agreement.

18. The undersigned has the right to extend or cancel the tender without assigning any reason.
19. All Documents uploaded online by the Bidders including affidavits shall be considered in technical bid evaluation but after award all the documents may be duly verified.
20. Bidders should have valid registration with Employees Provident Fund organization under EPF and Miscellaneous Act, 1952.
21. Bidders can access tender documents on the website <http://pmgsytendersbih.gov.in> and submit the completed tender documents in electronic form on the website itself. Bidders shall upload scanned copies of all required papers and certificates as required in the eligibility criteria. All papers uploaded will be treated as digitally signed. The scanned copies should be of original papers and certificates. If any uploaded paper found forged and fabricated, then appropriate action will be taken against the bidder as per clause 32 of ITB and clause 11 of "Bihar Contractor Registration Rule (Rural Works Department) 2007".
22. (a) Each bidder must upload an affidavit as per format in Appendix to ITB (SBD) clause 4.4 B (b) (i) for availability of construction equipment and Lab equipment either owned, or on lease or on hire.
(b) Each bidder must upload an affidavit for availability of Key Personnel as per format in Appendix to ITB (SBD) clause 4.4 B (b) (ii).
23. Audit reports (issued after 30.06.2019) uploaded by bidders must have UDIN (Unique Document Identification Number) otherwise it will not be considered in evaluation of Bid.
24. Following points are to be followed for bridges having Deep foundation:-
(i) Pile integrity test, Ultrasonic Pulse Velocity Test and Dynamic Pile Load Test shall also be required to be done for ensuring the strength and quality of concrete cast during execution and forms part of Quality Assurance by the contractor. Thus, the cost towards this end needs to be included in the bid by the bidder.
(ii) Acceptance load test on one span before opening to traffic to observe the overall behaviour of the structure is required by the bidder. The cost towards this end needs to be included in the bid by bidder.
25. The result of evaluation of Part-I (Technical Bid) shall be made public on e-procurement following which there will be a period of 5 working days from the date of uploading the result of Technical Bid Evaluation during which bidders, who participated in the bid, may submit complaint which may be considered for resolution before opening of Part- II (Financial Bid) of the bid. Any complaint received from bidders beyond 5 working days from the date of **uploading of result** of Technical Bid shall not be entertained.
In case the decision is changed after redressal of complaint of all issues raised by bidders during the 5 working days already allotted, then further 3 working days from the date of uploading of Re-technical result will be allotted. During this period, representation /complaint regarding only about the change in the decision of the committee in the Re-technical Evaluation shall be entertained. No fresh complaint on other bidders/ issues shall be considered.
In case if there is no change in the result after re-technical evaluation then the process of opening of financial bid / retender shall be done as per direction on the minutes of meeting of the re-technical evaluation.
Above complaint/Representation shall be on Affidavit supported with evidence. Complaint without evidence & affidavit shall not be entertained.
