All disbursement shall strictly only be made as per the condition of agreement against certified completed works after ensuring full compliance with specification mentioned in BOQ, Satisfactory quality control report from the competent authority and after due inspection of works under payment by the competent authorities like NQM/SQM. All DDOs must ensure not to pay on such works against which "Unsatisfactory" or "SRI" grading is pending to regrade ipn satisfactory grading.
3. The total payment must not exceed the agreement amount for the Works/Package.
4. Prior approval of RWD shall be necessary for any payment in liabilities and deducted liquidity damage of the Road works /package.
